1. ADMINISTRATION OF THE TOURNAMENT

The administration and conduct of the Midwest Region Volleyball Crossover Tournament shall be under the jurisdiction of the Tournament Committee (GLVC, GLIAC, GMAC staff representatives and head official). Tournament duties specifically include:

- a) Oversight of event management
- b) Oversight of media operations
- c) Authority to handle incidents of misconduct

2. ADMITTANCE TO THE MIDWEST REGION VOLLEYBALL CROSSOVER TOURNAMENT

Credentials will be distributed to each team for team personnel (head coaches, assistant coaches, athletics trainers, etc.). There will be no credential needed for student-athletes. Those passes will be provided in your tournament packets, which will be available at the team practice session on Thursday. You must have one of the following to be admitted to the Great Lakes Center:

- a) Purchased ticket
- b) Team uniform
- c) Credential: Coaches, Media, Staff

3. ATHLETIC TRAINING SERVICES

A certified athletic trainer will be on-site for all contests for first aid and emergency care. If your team will be traveling without a certified athletic trainer or athletic training student, Jillian Stapf from the Great Lakes Center will be happy to assist your team with taping/wrapping that may be needed. There will be one athletic trainer at the Great Lakes enter starting two hours prior to the first matches and will stay until the last matches end. They will have hot packs and ice available for student-athletes but do not have any other modalities (i.e. ultrasound, e-stim, game ready, etc.) available for use. Jillian will be available in the training room 60 minutes prior to the first practice session and 90 minutes prior to competition sessions. Please contact Jillian if you need additional information.

4. ARTIFICIAL NOISEMAKERS

Artificial noisemakers of any kind will not be allowed in to facility during the event.

5. BANNERS

Handheld signs are permitted at the discretion of the tournament committee. Items that may interfere with or obstruct spectators' view will be removed.

6. CONCESSIONS

Concessions will be operated by the Great Lakes Center throughout the event. The concession area is on the second floor of the facility. Outside food and drinks are not permitted.

7. DESIGNATION OF HOME TEAM AND UNIFORM COLORS

The GLVC will be the home team on Friday and the GLIAC will be the home team on Saturday. G-MAC teams will dress opposite their opponent. The home team shall occupy the bench closest to the balcony side of the facility. On Friday, the GLVC teams will wear light colored uniforms and the GLIAC teams will wear dark colored uniforms. On Saturday, the GLIAC teams will wear light uniforms and the GLVC teams will wear dark uniforms.

8. EVENT MANAGEMENT STAFF

The event management staff will be comprised of representatives from the GLVC, GLIAC and G-MAC conference offices. The home base for event management operations will be the first-floor conference room adjacent to the Great Lakes Center main offices. Any issues or questions that arise should be directed to the event management staff. A committee composed of representatives from all three conferences and the GLIAC Supervisor of Officials will have the authority to address any issues that arise, including disciplinary action if inappropriate conduct occurs.

9. GREAT LAKES CENTER

The site of the 2017 Midwest Region Volleyball Crossover Tournament is the Great Lakes Center and is located at 579 North Oakhurst Dr., Aurora, IL, 60502. The facility includes twelve courts, which will all be used concurrently during tournament play. All courts will be clearly numbered. The officials will address any ground rules specific to the venue or to a particular court prior to the start of the match. There are bleachers that provide spectator seating on each court.

10. HOSPITALITY AREA

On-site hospitality will be provided for all tournament games. The hospitality area for coaches, VIP, media and tournament staff is located on the second floor and will be portioned from the general public. Student-athletes and spectators will not be permitted to enter the hospitality area at any time.

11. LOCKER ROOMS

The locker rooms will NOT be available for use by participating teams. The facility will not provide towels so teams are responsible for bringing their own. In addition, the fitness area is available for team meetings and the upstairs area provides space for team bags and meetings. All team bags should be stored on the second floor during competition on Friday and Saturday. There will be a curtained area located on the second floor portioned from the public for teams' access throughout the event.

12.MATCH PROTOCOL

The Match Protocol for the 2017 Midwest Region Volleyball Crossover Tournament will be as follows for all first session matches or when time allows for both Friday and Saturday:

60-minute protocol

Minute 36 Shared Court Time

Minute 19 Visiting Team Full Court

Minute 15 Home Team Full Court

Minute 11 Visiting Team Hitting

Minute 6 Home Team Hitting

Minute 0 National Anthem (first match only)

*All times prior to match protocol will be considered shared court time for ball handling ONLY.

If the 60 minutes does not present itself between matches, an alternate warm-up protocol will be applied to guarantee a minimum of 40 minutes.

40-minute protocol

Minute 34 Visiting Team Full Court

Minute 28 Shared Court Time

Minute 19 Visiting Team Full Court

Minute 15 Home Team Full Court

Minute 11 Visiting Team Hitting

Minute 1 Team Huddle/Announcements

*The National Anthem will be played prior to the first match only on Friday and Saturday. If a session runs long, tournament administrators will adjust start times as necessary to accommodate statistical and official staffing.

13.MERCHANDISE

Tournament t-shirts will be provided by the G-MAC and sold for \$20. Preorders for merchandise will be available during the practice sessions or on competition days at the merchandise table near the main entrance to the facility.

14. NATIONAL ANTHEM

The National Anthem will be performed prior to the first match each day.

15. OFFICIALS

Jeanne Skinner, GLIAC Supervisor of Volleyball Officials, is coordinating the officiating schedule. There will be two officials and two line judges for each match. The G-MAC will pay officials and provide hotel rooms for those needing overnight accommodations.

16. PARKING

Bus parking is available in the lot west of Oakhurst Drive, across from the main entrance to the Great Lakes Center.

17. PRACTICE TIMES

Practice times on Thursday, Oct. 12 are available in one-hour blocks between 5-8 p.m. (CT). The practice schedule is included in Appendix D.

18. SCORING TABLE PERSONNEL

Each team will be responsible for providing three to six individuals (based on schedule) to assist with scoring table operations for their assigned match(es). The scoring table responsibility schedule included with the manual materials in Appendix D. COACHES: IT IS IMPERATIVE THAT YOUR PLAYERS ARRIVE AT THE SCORING TABLES 20 MINUTES BEFORE THE MATCH STARTS.

19. SHOWER FACILITIES

Two sites have been secured for shower services to all 36 teams and are as follows:

Game Balls: The tournament game balls will be provided by Molten


